About the journal

Modern Rheumatology Case Reports is an international, peer reviewed journal, publishing high-quality content.

Aims and scope

Modern Rheumatology Case Reports is an online-only journal dedicated to publishing original single and series case reports and letter in English on rheumatism, connective tissue diseases, musculoskeletal disorders including osteoporosis, orthopedic/spine surgery, rehabilitation and their associated areas such as pathology, physiology, immunology, microbiology and pharmacology. We encourage case reports worthy of discussion and clinical lessons particularly around aspects of differential diagnosis, decision making, management, treatment approach, uncommon adverse events, clinical guidelines and pathology.

Letters should be limited to commentaries on previous reports published in *Modern Rheumatology Case Reports*, subjects related to rheumatology and topics of potential interest to the readers. Papers are welcomed from members of the Japan College of Rheumatology and non-members alike.

Submissions should be made through the journal's online submission system. All submissions are subject to single blind peer review and will only be published after peer review. Articles should not be under review by any other journal when submitted to *Modern Rheumatology Case Reports*.

Peer review

Papers are subject to peer review by at least two referees and the Editors, and to editorial revision of the language and contents. The Editorial Board is responsible for the acceptance, rejection, and order of publication of papers. If authors are requested to revise and resubmit the paper, it should be completed within 2 months. Failure to do so will constitute a withdrawal from publication.

Plagiarism

Modern Rheumatology Case Reports has a strict policy against plagiarism. We define plagiarism as the use of extracts from another person's work that are not placed in quotation marks, without the permission of that person, and without acknowledgement to that person (using the appropriate reference style), with the result that your article presents these extracts as original to you. By submitting your work to *Modern Rheumatology Case Reports*, you warrant that it is your original work, and that you have secured the necessary written permission from the appropriate copyright owner or authority for the reproduction of any text, illustration, or other material. If any article submitted to *Modern Rheumatology Case Reports* is found to have breached any of these conditions, the Editorial board reserves the right to reject that article and any others submitted by the same authors. The Editorial board may also contact the authors' affiliated institutions to inform them of its findings.

Preparing your paper

Modern Rheumatology Case Reports is a signatory journal to the Recommendations for the Conduct, Reporting, Editing, and Pub-

lication of Scholarly Work in Medical Journals, issued by the International Committee of Medical Journal Editors ([ICMJE Recommendations](#)), and to the Committee on Publication Ethics ([COPE](#)) code of conduct for editors. Modern Rheumatology Case Reports are pleased to support the Case Report ([CARE](#)) guidelines: clinical case reporting guideline development.

Patient consent

Publication of any personal information about an identifiable living patient requires the explicit consent of the patient or guardian.

You must have signed informed consent for publication from patients (or relatives/guardians) before submitting to *Modern Rheumatology Case Reports*. Please anonymize the patient's details as much as possible, eg, specific ages, ethnicity, occupations. For living patients this is a legal requirement and we will not send your article for review without explicit consent from the patient or guardian.

If the patient is deceased the Data Protection Act does not apply, but the authors must obtain permission from a relative (ideally the next of kin).

The signed consent form(s) should be retained by the corresponding author. Since the consent form needs to comply with the relevant legal requirements of your particular jurisdiction, we do not provide sample forms; this is your responsibility. Your affiliated institution should be able to provide an appropriate form. This documentation must be made available to the Editor if requested, and will be treated confidentially. The editors reserve the right to request ethical approval/patient consent associated with a particular paper. The final decision on whether consent to publish is left to the discretion of the editors.

Manuscript form

All manuscript, including the abstract, text, acknowledgements, references, figure legends, must be written in English, typed double-spaced with wide normal margins in A4-size format.

Authors whose native language is not English must seek the assistance of a colleague who is a native English speaker and is familiar with the field of the work.

Standard abbreviations and units should be used. Abbreviations should be defined at first appearance, and their use in the title should be avoided. Generic names of drugs and chemicals should be used.

Length of articles

Please include a word count for your paper. A Case Report for this journal should not exceed 8,000 words, including tables, figure legends and all references.

Letters should not exceed 2000 words, with no more than 1 figure and 10 references.

Style guidelines

Please refer to these [quick style guidelines](#) when preparing your paper, rather than any published articles or a sample copy.

Please use double quotation marks, except where "a quotation is 'within' a quotation". Please note that long quotations should be indented without quotation marks.

Formatting and templates

Papers may be submitted in any standard format, including Word and LaTeX. Figures should be saved separately from the text. To assist you in preparing your paper, we provide formatting template(s).

Checklist: what to include

1. **Title page.** Please include all authors' full names, affiliations, postal addresses, telephone numbers and email addresses on the cover page. One author will need to be identified as the corresponding author, with their email address normally displayed in the online article. Authors' affiliations are the affiliations where the research was conducted. If any of the named co-authors moves affiliation during the peer-review process, the new affiliation can be given as a footnote. Please note that no changes to affiliation can be made after your paper is accepted. [Read more on authorship](#).
2. A non-structured **abstract** of 250 words. The abstracts are not required for Letters to the Editor. [Read tips on writing your abstract](#).
3. **5 keywords.** Read [making your article more discoverable](#), including information on choosing a title and search engine optimization.
4. **Text.** The text should be divided into the following sections: introduction, case presentation, results (when necessary), and discussion.
5. **Patient consent.** All persons gave their informed consent prior to their inclusion in the report and it should also be stated clearly in the text.
6. **Ethical Statement.** In the Methods section, please include the Ethical Statement as instructed. If your manuscript does not report on or involve the use of any animal or human data or tissue, please state "Ethical Approval Statement was not required for this manuscript" or "Ethical Approval is not applicable." in this section.
7. **Funding details.** Please supply all details required by your funding and grant-awarding bodies as follows:

For single agency grants
This work was supported by the <Funding Agency> under Grant <number xxxx>.
For multiple agency grants
This work was supported by the <Funding Agency #1> under Grant <number xxxx>; <Funding Agency #2> under Grant <number xxxx>; and <Funding Agency #3> under Grant <number xxxx>.
8. **Conflict of interest.** Authors must disclose any financial or personal relationships that may pose conflicts of interest. In the manuscript, all such relationships must be declared in a separate section "Conflict of interest" before the reference list. If no conflict of interest is declared, then "None" should

be inserted in this section. [Further guidance on what is a conflict of interest and how to disclose it](#).

9. **Certification form.** The Certification form must be signed handwritten by all authors and submitted with submission. Upon receipt of this signed form, manuscripts are officially recognized as submissions. The signed form may be uploaded through the submission system (Editorial Manager).
10. **Supplemental online material.** Supplemental material can be a video, dataset, fileset, sound file or anything which supports (and is pertinent to) your paper. We publish supplemental material online via Figshare. Find out more about [supplemental material and how to submit it with your article](#).
11. **Figures.** Figures should be high quality (1200 dpi for line art, 600 dpi for grayscale and 300 dpi for colour). Figures should be saved as TIFF, PostScript or EPS files.
12. **Tables.** Tables should present new information rather than duplicating what is in the text. Readers should be able to interpret the table without reference to the text. Please supply editable files.
13. **Equations.** If you are submitting your manuscript as a Word document, please ensure that equations are editable. More information about [mathematical symbols and equations](#).
14. **References.** References should be cited using Vancouver referencing style when preparing your paper.

Compliance with ethics of experimentation

Authors must ensure that research reported in submitted manuscripts has been conducted in an ethical and responsible manner, in full compliance with all relevant codes of experimentation and legislation. All manuscripts which report in vivo experiments or clinical trials on humans or animals must include a written Statement in the Methods section that such work was conducted with the formal approval of the local human subject or animal care committees, and that clinical trials have been registered as legislation requires. If your manuscript does not report on or involve the use of any animal or human data or tissue, please state "Ethical Approval Statement was not required for this manuscript" or "Ethical Approval is not applicable." in this section.

Authors must confirm that all mandatory laboratory health and safety procedures have been complied with in the course of conducting any experimental work reported in the manuscript; and that the manuscript contains all appropriate warnings concerning any specific and particular hazards that may be involved in carrying out experiments or procedures described in the manuscript or involved in instructions, materials, or formulae in the manuscript; and include explicitly relevant safety precautions; and cite, and if an accepted standard or code of practice is relevant, a reference to the relevant standard or code. Authors working in animal science may find it useful to consult the [Guidelines for the Treatment of Animals in Behavioural Research and Teaching](#).

Using third-party material in your paper

If you wish to include any material in your paper for which you do not hold copyright, you will need to obtain written permission from the copyright owner prior to submission. More information on [requesting permission to reproduce work\(s\) under copyright](#).

Submitting your paper

Modern Rheumatology Case Reports uses the submission system Editorial Manager to manage the submission process. New users should first create an account. Once logged on to the site, submissions should be made via the Author Centre. Online user guides and access to a helpdesk are available on this website.

Please note that *Modern Rheumatology Case Reports* uses CrossCheck™ to screen papers for unoriginal material. By submitting your paper to the journal you are agreeing to originality checks during the peer-review and production processes.

There are no submission fees or page charges for this journal. Colour figures will be reproduced in colour in your online article free of charge.

Copyright transfer

It is a condition of publication that authors assign copyright or license the publication rights of the contents of their articles, including abstracts, to the Japan College of Rheumatology. This enables full copyright protection and dissemination of the article and the Journal, to the widest possible readership. A document to verify this will be sent upon acceptance for publication. This document should be signed by the corresponding author and returned to the publisher for archiving.
